\*Please note the above date is in order for us to apply funding to your child's account before we issue invoices. HMRC dates are as follows: 31st December – 31st March – 31st August.

## Who is eligible for 15 hours funding?



All 3 to 4-year-olds in England are eligible for 570 funded hours per year until the term in which they start Reception or reach compulsory school age (the term following their 5th birthday).

There are no earning or work requirements. Working parents with children aged 9 months – 3-4 year-olds may be eligible for an additional 15 hours. Check your eligibility on the Best Start in Life website.

## 15 hours funding

When accessing your full entitlement, a maximum of 5.59 hours per day for 15-hour-funded children will be applied on any one day (see chart on the right-hand side).

Funding will be allocated to full-day sessions (08:00–18:00). Children who attend all year around will have their funding stretched over 51 weeks, receiving up to 11.18 funded hours per week in two days, totalling 570 hours per year. Parents will pay the remaining 4.41 hours per day.

15-hour funding may also be available for two-year-olds of families in receipt of additional support (FRAS) (see our Funded Childcare Guide for more information).

## Who is eligible for 30 hours funding?

All eligible working parents of children aged 9 months to 3-4 years can access 30 hours of funded hours childcare per week for 38 weeks of the year. We operate all year around so funding is stretched across the year as per the below. This is wonderful news for our families, meaning that children can access more nursery education and achieve better value for money.

Eligibility can be checked on the Best Start in Life website.

## 30 hours funding

When accessing your full entitlement, a maximum of 7.45 hours per day for 30-hour funded children will be applied in any one day (see chart to the right hand side).

Funding will be allocated to full-day sessions (08:00–18:00). Children who attend all year round will have their funding stretched over 51 weeks, receiving up to 22.35 funded hours per week and totalling 1140 hours per year. Parents will pay the remaining 2.55 hours per day.

These funding arrangements are aligned with our Funding Guide and Funding Contract.

Funded only options are available. These can be accessed as 10 hours per day of funding, stretched over 51 weeks. See below example:

## Discounts

We offer a range of 5% discounts, including Eldest Sibling Discount, Full-Time Discount, NHS Discount, and Military Discount. Each child can receive up to two discounts: the Eldest Sibling Discount and one other. If the Eldest Sibling Discount is not applied, an individual child may receive a maximum of one discount.



## Booking patterns

We recommend your child should attend a booking pattern of 2 days ensure your child settles at nursery.



## Tax-free childcare

You can get up to £500 every 3 months (up to £2,000 a year) for each of your children to help with the costs of childcare. This goes up to £1,000 every 3 months if a child is disabled (up to £4,000 a year).

You can get Tax-Free Childcare at the same time as 30 hours of funded hours childcare through Free Childcare for Working Parents if you're eligible for both.



## \*Registration fee

Registration fee is not charged for fully funded places. It applies on every other application. The registration fee is also applicable to re-applications after leaving the nursery.
